Terms and Conditions for the 2017 BWCAA Cattle Sale

Seller/consignor Fees: Seller/consignor agrees to pay 10% of the winning bid to BWCAA. Should the seller put a reserved price on the animal and does not sell it at that price; he/she agrees to pay 6% of the last bid to help cover BWCAA Sale expenses. He/she also agrees that the animal will not be sold within a 5-day period after the sale without paying the full 10%.

Terms: Terms of the sale are cash or check payable immediately upon conclusion of the Sale and before animals will be moved. Seller will reserve the right to require a certified check as settlement before releasing any cattle.

Insurance of Purchases and Risk: All animals are the seller's risk prior to their sale and become property of the buyer as soon as declared sold by the auctioneer.

Bidding: All animals sell to the highest bidder. Any dispute or challenges regarding bids will be settled by the auctioneer and his decision will be final.

Health and Export: A veterinarian will be on hand to write interstate health certificates.

Registration and Transfer: All animals sell with registration papers from the BWCAA and will be transferred after the sale. The transfer fee is waived for this sale.

Announcements: Any errors or changes of information contained in the catalog will be announced from the auction block and such announcements shall take precedence over information contained in the catalog.

Breeding Guarantee: Every effort will be made to make the most up-to-date information regarding pregnancy check available to the buyers of females listed as bred. The seller has to have had the animal examined by a veterinarian and found to be safe in calf.

Bulls: Documentation proving a test for Trichomoniasis within 30 days prior to the Sale for bulls 12 months or older must be presented upon check in.

Open Heifers: The open heifers selling are guaranteed to be breeders. If a female appears to be a non-breeder within 6 months of the sale (or within six months of when she reaches breeding age) she may be returned to the seller at the buyer's expense. The seller will then reserve the right to prove the animal a breeder within a six month period, using any registered British White bull of his choice through A.I or natural service. If successful, seller will return the animal to the buyer, again at the buyer's expense. Should the animal fail to prove a breeder, the seller, at his option, may either return the purchase price to the buyer, or replace the animal with another of equal value in full settlement and satisfaction of all claims. In no event shall the seller be responsible for more than the purchase price. In case the animal in question should develop to be a problem breeder due to negligence or improper management by the buyer or if the female has been subjected to any hormonal or surgical reproduction techniques, the seller's guarantee does not apply. No guarantee is given that bred females will deliver a live calf. No guarantee is given that a female will produce eggs suitable for transplant.

Liabilities: All persons who attend the sale do so at their own risk and Auctioneer, Eric Brown, and BWCAA and guest consignors assume no liability for any accidents that may occur. Neither does Eric Brown nor BWCAA and guest consignors assume any liability for loss or injury to livestock due to theft, mysterious disappearance, sickness, improper handling or Act of God. It is also to be clearly understood that Auctioneer, Eric Brown, and BWCAA acts only as a medium between buyer and seller. They are not responsible in any way for any failure on the part of the buyer and the seller to live up to their obligations or for the truth of any warranties or representations, express or implied. Neither does Auctioneer, Eric Brown, assume any financial obligation to collect or enforce collection of monies between parties. Any legal action that may in exceptional cases be taken must be between the buyer and seller.

Contract: The above terms and conditions shall constitute a contract between the buyer and seller of each animal sold.

Mail Bid: Mail or wire bids may be furnished. Bids must be in the hands of the sale manager in ample time prior to the sale and will be handled in strict confidence.

Guidelines for Entering Animals in the 2017 BWCAA National Cattle Show and Sale

1. All animals entered in the Show and Sale must be registered with BWCAA and be Standard Marked as defined found on page 10 of the BWCAA Breeders Reference Guide. Should any animal be of questionable coloring standards, a photo of the animal should be submitted with the entry form (digital photos can be emailed to the office). The Sale Committee will determine if the animals meet the Standard Marked definition. It is also recommended that photos be submitted with the entry forms so that they may be shown in the Sale Catalog and on the Association website.
2. The deadline for entering animals in the Show is September 15, 2017.
3. For the Sale, animals may be consigned up to the day of the Sale. However, to be listed in the Sale Catalog, entries must be consigned by August 5th 2017.
4. Animals consigned to the Sale will be mailed BWCAA ear tags with their lot number. It is recommended that these be put in their ear prior to arriving at the Sale. Working facilities are limited at the Sale site.
5. Upon arrival, all livestock exhibitors are to report to the appropriate office to receive stall or pen assignments and to turn in any required paperwork. Once an animal is unloaded from a trailer at the show grounds, said animal may not enter the trailer again until departing the show facility not to return. Any animal found entering a trailer during the show will be immediately disqualified. **If for any reason an animal does need to re-enter a trailer it will be at the discretion of the Show Committee. All show animals are subject to random tattoo checks.
6. BWCAA reserves the right to accept or reject any entry, to limit entries to available facilities, and to limit the number of entries by an exhibitor in the Show. The return of entries done under this rule will be done generally and without discrimination on a "first come, first served" basis. BWCAA reserves the right to

return entry fees and cancel any class in which there are insufficient entries to secure adequate competition.

7. In order to show an animal, one must be a BWCAA member (Active, Associate or Junior) in good standing, but need not own the animal.
8. All animals entered in the Show and /or Sale, including cow/calf pairs must have a Certificate of Veterinary Inspection (CVI) also called a “health certificate” issued by a veterinarian within 30 days prior to the Show/Sale **plus** an Identification Ear tag. Ear tags can be any one of three types:
 - A Brucellosis (BANGS) tag, which is considered a uniform ear tag as long as the number on that tag is stated on the CVI.
 - A National Metal Uniform Ear Tag (NUES) from your State Board of Animal Health. You will need your Premises number from them or can get one from them. Using your Premises number, you can order those tags free of charge. You can either have the vet put them on or do it yourself. Each tag will be unique and would be entered by your vet on the CVI.
 - Or a USDA 840 series visual ear tag or EID (Electronic Identification) tag with an Animal Identification Number.
 - For animals entering Oklahoma **from California and Michigan**, two additional requirements are:
 - i. A **Prior Entry Permit** must be obtained from the Office of the Oklahoma State Veterinarian (405-522-0270) issued 15 days prior to arrival at the Show/Sale.
 - ii. A **negative TB test** within 60 days prior to the Show/Sale.
9. Bulls 12 months and older entered in the Show and/or Sale must have proof of a Trichomoniasis test dated within 30 days prior to the Sale.
10. Only animals participating in the Show or Sale are permitted to be on the grounds during the Show and Sale unless arranged for specific purposes by the Show manager.
11. Bulls 9 months old and older entered in the Show must have a nose ring or lead ring and be double tied at all times while in route to and from the Show Ring. Bulls need not be tied if they are in a stall.
12. All wall tied animals must be double tied (2 ropes, one being with a neck tie) at night.
13. All electrical equipment must be equipped with a ground wire. Proper utilization of extension cords is required. Portable electric generators must be equipped with ground fault interrupter outlets.
14. All pathways, building entrances and exits, pedestrian areas and approaches must be kept clean for the safety and convenience of all persons and livestock. All fans, tack, equipment, chairs, feed, supplies, blocking chutes and tables must be kept within stalls, tie space, pens and designated tack areas. Fitting equipment and activity must take place in designated areas. All exhibitors and Show officials must adhere to all Fire Marshal requirements.

15. All dogs must be kept on a leash at all times. Any dogs showing aggression to animals or persons must be removed from the grounds.
16. BWCAA reserves the right to use any and all photographs and films taken during the Show and Sale for publicity purposes.
17. A starting supply of bedding will be included in the registration fee for both the Show and Sale. Additional bedding must be purchased from the vendor on-site.
18. Park trucks and trailers only in designated areas.
19. Any protest, based on violation of the rules, may be submitted within 6 hours of the occurrence of the alleged violation to the Show manager. Protests will be adjudicated by the Show Committee whose decision is final.
20. Alcoholic beverages are not permitted at the McLain County Event Center.
21. Any exhibitor or exhibitor's family members causing public disturbances, or who become uncooperative, unsportsmanlike or not following good animal welfare or found in violation of the rules may be penalized by forfeiture of any privileges or awards. Further, if the exhibitor or exhibitor's adult supervisor, parent or family member's actions are deemed illegal, inhumane or unethical to livestock, the proper authorities will be notified.
22. The act of entering the 2017 BWCAA National Cattle show, is giving verification by the owner and exhibitor that they have read and understand the BWCAA Code of Show Ring Ethics
23. All exhibitors will be under the control and direction of the BWCAA Show Committee. Exhibitors shall indemnify BWCAA against any and all legal proceedings against damage or injury to any person or property caused by an exhibitor or consignor, his agents or animals.
